TERMS AND CONDITIONS

1. **APPLICANT PRIVACY:** It is DMH Agency's policy to respect the privacy of its applicants.
2. **REGISTRATION OBLIGATIONS:** By using any of DMH Agency services, you agree to provide true, accurate, current and complete information about yourself as prompted by the service's registration form. DMH Agency has the right to suspend or terminate your application if you violate the above or if DMH Agency has reason to believe that you have violated the above.
3. **DESCRIPTION OF SERVICE:** DMH Agency provides training, casting services and portfolio shoots. Our services are available to applicants who wish to have their applications viewed and evaluated by DMH Agency. By registering your information, submitting your application, you give DMH Agency permission to present or recruit you to Industry Experts and Associates for review. The Model hereby gives DMH Agency express permission to use written correspondence, photographs or other likenesses of the Model which result from the Model's professional services or test photo shoots to promote the reputation and/or services of DMH Agency, and/or its affiliated companies and the Model expressly waives any rights which the Model may otherwise have to such products or images.
4. **APPLICANT CONDUCT:** As an aspiring professional model, or parent of an aspiring model, you understand that you are expected to behave in a professional manner at all times. This includes your correspondence by email, telephone or fax with DMH Agency or its affiliated Companies. Applicants who use language that is deemed unlawful, harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, libellous, false or otherwise objectionable will have their application cancelled immediately. You understand that DMH Agency, in its sole discretion, may terminate your application at any time, for any reason and with prior notice.
5. **CHARGES AND BILLING:** You are responsible for all charges incurred and purchases made by you or anyone you allow to use your credit card, checking account, or other payment methods, including your children, other applicants, or your family or friends. You understand that all fees are NON-REFUNDABLE for any reason. If your cheque, debit order or credit card payment is returned or cancelled, for any reason, it will be re-deposited electronically, and you will be assessed a processing fee of R35 or the maximum amount allowed by law. The credit card user and/or cheque writer is also responsible for all other credit card and/or cheque recovery costs, including but not limited to attorney's fees, court cost, and other amounts allowed by law and these fees and costs will be electronically debited from your account. DMH Agency reserves the right to amend this refund, payment, and processing procedures and fees as stated herein.

6. **NO GUARANTEE OF SERVICE:** You understand that DMH Agency provides no guarantee of placement, employment or representation with DMH Agency or another agency. DMH Agency provides its services on a commercially reasonable basis and does not guarantee that users will be able to access or use the services at times or locations of their choosing. Specifically DMH Agency reserves the right at any time to modify or discontinue temporarily the service (or any part of the service) with notice. You agree that DMH Agency should not be liable to you or to any third party for any modification, suspension or discontinuance of its service.
7. **INDEMNIFICATION:** You agree to indemnify and hold DMH Agency, and its parents, subsidiaries, affiliates, officers, other partners, and employees, harmless from any claim, demand or damages, including reasonable attorney's fees, made by any third party due to or arising out of your content, your use of the service, your connection to the service, your violation of the Terms and Conditions for service, or your violation of any rights of another.
8. **NO RESALE OF SERVICE:** You agree not to reproduce, duplicate, copy, sell, rent, resell or exploit any portion of the service, use of the service or access to the service provided by DMH Agency.
9. **NOTICE:** ALL notices and communication to you will be made via email or SMS. The service may also provide notices of changes to the Terms and Conditions or other matters. Any Changes may also be done at any time.

GENERAL INFORMATION

1. By accepting this agreement you hereby accept the following terms and conditions as set out below:
2. Your fees are due before you receive any service.
3. Acknowledge that DMH Talent Agency deducts a 20% of payment as commission on all earnings generated through the business introduced by DMH Talent Agency. Outside agencies fees may apply, but will be disclosed to you upfront when applicable. You understand that earnings are not to be discussed on set – either with other artists or with production crew. You acknowledge that any monies you receive are taxable according to PAYE, please ensure that you disclose these earnings and understand that you are liable for this to SARS.
4. Should you commit to being at a casting or TV/Photo shoot, you will be there. If any problems arise on set, at a shoot or at a casting, you will notify a representative of DMH Agency immediately. If a personal matter arises on the day of a shoot, or at a shoot, on set or at a casting, you understand that you will be held accountable for all costs or damages incurred if your presence is absent. The above applies if you leave set before you have been wrapped and or dismissed.
5. You will arrive on time at any casting or shoot that you have committed to attend with the appropriate clothing. You understand that any clothing and/or accessories used in shoots are for your responsibility, and should something happen to them – you will be held liable.
6. Should any of your details (contact, measurements, hair colour/length, etc.) change, you will notify DMH Agency timeously and will make yourself available for ratification to your portfolio where necessary.
7. Should you wish to cancel your contract, you may do so in writing. If classes have been missed, the amount already paid will not be refunded.
8. There could be inflation of cost in any of our services, or changes to the contract whilst you are still in training or have any commitments with payments or anything else in the agency. You understand that you will abide by new statements added in the contracts and new costs that might arise due to inflations.

9. You will be professional and courteous at all times when representing DMH Agency or any other company contracted to DMH Agency.
10. You will not badmouth the agency or your peers at a casting or on a set. You undertake to do all you can to present a united front in the public eye, and keep your personal opinions to yourself to avoid conflict.
11. DMH Agency reserves the right to cancel this contract with immediate effect, should the above terms not be adhered to.
12. Any photographs/videos of you or that may include you may be used by DMH Agency on our website, social media sites and any marketing platforms.

Training Course:

Your online training course will commence on two Thursdays a month from 6pm-7pm for the duration of five months. The course consists of a range of classes done by various facilitators to create more versatile and educated performers. You must have the Zoom App set up and have an account created. This must be downloaded on a device with a front camera and your email already set up. The training course is compulsory for any new artist.

Portfolio Shoot OR Portfolio Material:

Professional photographs will be taken by our photographers. You will receive a copy of all images, printed images, Z cards and hard copy of your portfolio book. Alternatively, you may provide us with your own professional images and if they are of standard, we will compile your portfolio utilising your own images.
